INSURANCE

Club Super automatically provides you with Income Protection insurance for 100% of your salary. If you're aged 24 or under, you automatically receive 1 unit of Death cover and 2 units of TPD cover. If you're aged 25 or over you automatically receive 2 units of Death cover and 2 units of TPD cover. This is the 'default' number of units. You can elect to have up to 3 additional units of Death and TPD cover without the need to provide medical evidence. If you require more than 3 additional units, Club Super will send you an Insurance Cover Form or a personal statement to complete. The value of unit based cover decreases as you get older. As an alternative, you may apply for fixed cover (with premiums then increasing as you get older). However, the minimum amount of 'fixed' cover you must have is equivalent to the value of 1 unit (based on your current age). Please refer to the Insurance section of this PDS for further information. Under either option, you may apply for more Death & TPD cover. **IMPORTANT: IF YOU DO NOT COMPLETE THIS SECTION YOU WILL AUTOMATICALLY RECEIVE THE DEFAULT LEVEL OF DEATH AND TPD COVER ACCORDING TO YOUR AGE AND INCOME PROTECTION COVER. THE COST OF THE INSURANCE COVER WILL BE DEDUCTED FROM YOUR ACCOUNT.**
